TOURNAMENT RULES

- 15,000 tournament chips.
- Levels will last 15 minutes.
- One (1) in ten (10) players will receive direct seats into the \$400 Mega Stack Ring Event Flight A, the \$1,100 DeepStack NLH Ring Event, the \$300 Black Chip Bounty / Ambassador Bounty Ring Event, and the \$800 Main Event Flight A, plus \$400 cash, for a total of \$3,000. Residual seats and/or prize money in that order will be awarded to the player who finishes after all seats are awarded.
- A single ante will be paid from the big blind for each hand. The ante is paid after the big blind. The ante will not reduce.
- There will be a 15-minute registration break at the completion of Level 6.
- On-site registration and re-entries are available until the start of Level 8 of this event at approximately 12:45PM.
- An eliminated player may re-enter the event. Alternates and late sign-ups will enter the tournament with a full chip stack and no obligation from it.
- · Seating may be limited for this event.
- TDA rules apply. Tournament Director's decisions are final.
- Management reserves the right to alter, change, or cancel this tournament. Management
 will not be held responsible in the event of typographical errors or misinformation on the
 website or printed material pertaining to this event.
- Winners will be paid in casino chips.
- All tax laws, foreign and domestic, apply. Winners must show a valid ID to collect winnings. Residents of foreign countries without a U.S. tax treaty will be subject to withholding. Pursuant to new IRS regulations, W-2G or 1042 forms will be issued for all tournament winnings of \$5,000 or more (net of buy-in amount).
- \$300 will go towards the prize pool. \$50 will go towards the administrative fee, which
 includes all staffing/dealer fees and rake.
